## **District Asking for Help**

The District is asking customers to please help keep their meter box lids visible and accessible at all times. Landscaping such as mulch and rocks should not be spread over the tops of the black lids of a customer's meter box. Trees and shrubs should also not cover the boxes. Inframark needs access to these boxes.

The District respectfully asks each customer to please check that your water meter box is easily visible and accessible. Customers who don't know where their meter is located should contact the District office and ask for help. It is important to know where the box is located in case any water-related problems occur on your property.

The District is also in the process of retrofitting the electronic part of each customer's metering system. New endpoints are, or will be, attached to the lid of the meter boxes so if opening, please do so carefully. The plan is to have all meters updated by the end of 2025.

## Wastewater Treatment Plant Construction Progress


July proved to be another busy month at the construction site of the new Wastewater Treatment Plant (WWTP). Associated Construction Partners (ACP) is the general contractor of the multi-million dollar project. At the last progress meeting, ACP reported approximately 31 percent of the project is completed.

On June 28, aerators were delivered and ACP removed a section of the concrete driveway towards the back of the plant.

On July 8, ACP surveyed and staked each proposed manhole location at the plant. July 11, the 8-inch effluent pump discharge bypass piping was relocated and the area by the culvert crossing which leads to the entrance of the construction offices was restored. July 18, ACP obtained elevation and radial measurements at the top of the wall of the effluent concrete ground storage tank (GST) as part of the proposed geodesic dome roof.

Heavy rains on July 22 caused a separation in the bypass pipe resulting in a backflow from the effluent GST and a large spill. Fortunately most of the effluent was contained in the large excavated hole at the construction site and the District's effluent pond. Clean up commenced immediately and TCEQ was contacted.

The next several weeks ACP will work on installing manholes, underground piping and mechanical equipment.

#### Permanent mandatory watering schedule

Irrigate outdoors using automatic or manual irrigation systems or hose-end sprinklers no more than **TWICE per week** for up to **15 hours** and only during scheduled days and times as indicated below:

#### **Residential**

Odd number addresses: Wednesdays and Saturdays Even number addresses: Thursdays and Sundays

Commercial (including large landscapes such as POA & Townhouse common areas) Tuesdays and Fridays

Watering Hours Midnight to 10 a.m. and 7 p.m. to midnight
